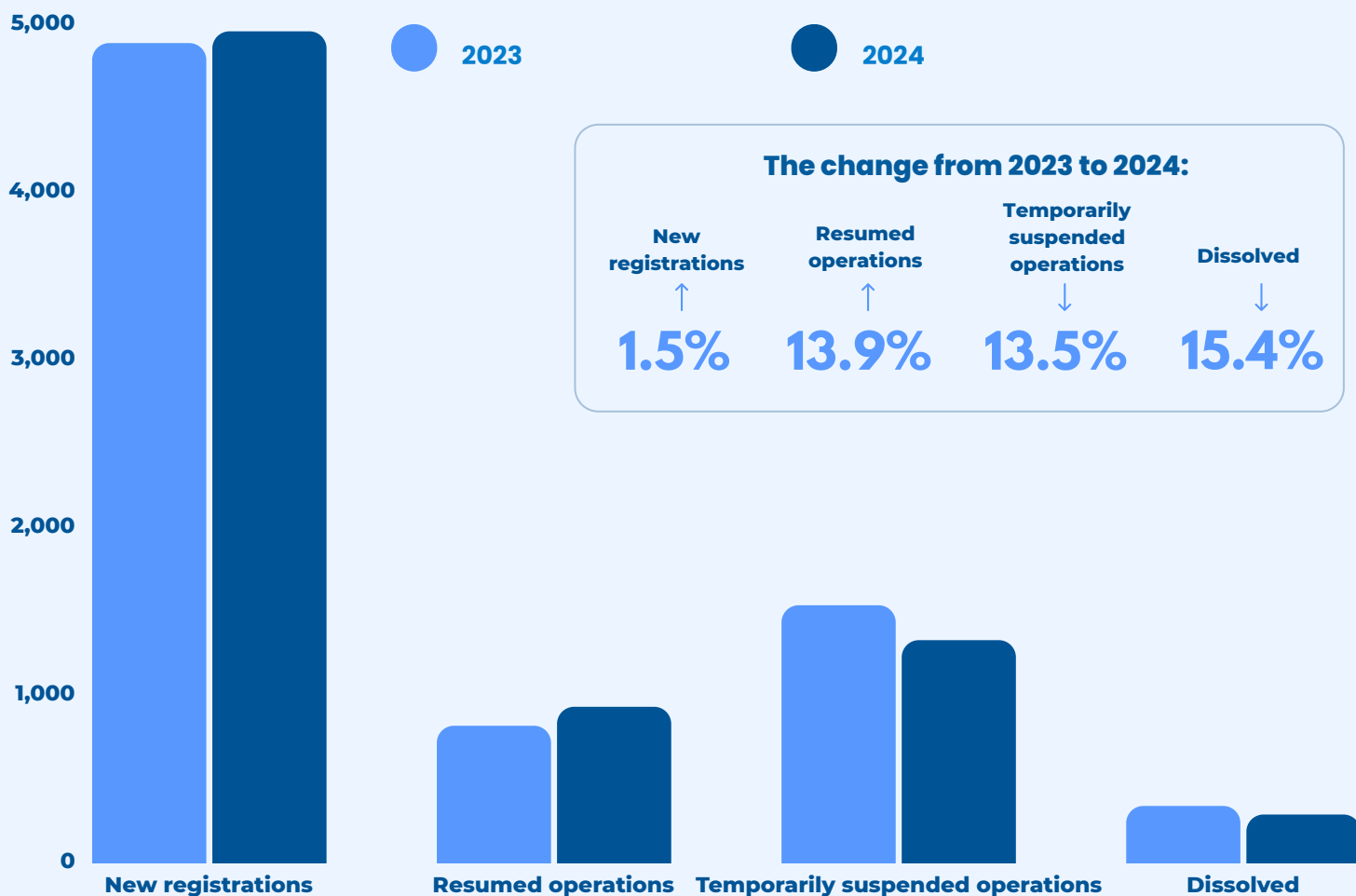

In March 2024, the enterprise registration situation in Ho Chi Minh City continued to reflect the positive recovery and development of the economy in the area.

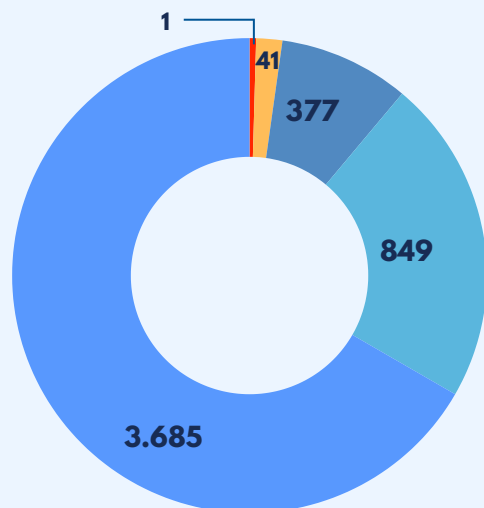
Enterprise Registration Trends in Ho Chi Minh City (2023 & 2024)
